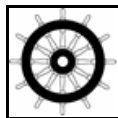

Application/Limitation

Approved for use throughout the accommodation as upholstery fabric for upholstered furniture.

Tested with standard non-flame-retardant flexible polyether foam of density of about 22 kg/m³.
Approved foam with higher density than used during testing may be used as filling material.
